Dear Friends of The Legal Clinic,

While the Whitehouse declared June 2023 as Immigrant Heritage Month, the current U.S. administration is issuing head-spinning immigration policies that have a direct impact on TLC clients in Hawai'i. Following the much-anticipated end of the Title 42 public health order which was applied to reject many asylum-seekers throughout the pandemic, the Biden administration recently extended the temporary protected status for El Salvador, Honduras, Nepal, and Nicaragua; thus continuing to offer protection to those escaping political turmoil or war at home. Many are now able to work legally in the U.S. for at least two years, filling jobs in understaffed sectors such as construction and agriculture.

Meanwhile, according to the National Immigration Justice Center, a sudden drop (70% in May) in unlawful U.S. southern border entries may have to do with a new asylum transit ban which "appears designed to rush people through to deportation without legal advice or representation". Tens of thousands are forced to return to the untenable and often violent conditions from which they tried so desperately to escape without the opportunity to access the very system that is supposed to protect them.

The focus on the southern border is also requiring USCIS to shift a significant portion of its finite resources, resulting in longer processing times for other immigration applications, including for our Hawai'i based clients awaiting family-based petitions or asylum interviews. To stay apprised of the latest policies that impact our clients, TLC's legal team consults regularly with the U.S. Citizenship and Immigration Service and with our national and local affiliates.

As always, we are grateful to all those who contribute to this important human rights work in uncertain times.

The Campaign for Universal Representation

TLC Legal Team on Hawai'i Island March 6-7, 2023



In March 2023, TLC senior attorney Omar Vaguerano and paralegal Lia Nakao traveled to Hawai'i Island to expand outreach and establish relationships with community service providers on neighbor islands. In Hilo, Omar and Lia joined Tulpe Day of the Hawai'i County Office of Immigration Services and Linda Spencer of Catholic Charities-Hilo in leading a public presentation on family-based immigration and providina in-person consultations issues to attendees. In Kona, TLC's legal team met with community healthcare workers at West Hawai'i CommunityHealth Center and provided legal counsel to Spanish-speaking patients in need of immigration services. The trip was successful in providing access to legal services to constituents beyond O'ahu, with TLC agreeing to represent eight new clients on Hawai'i Island.

June 2023: Unifying Pride & Immigrant Heritage Month



TLC advocates for equity, justice, and inclusion, and recognizes the countless ways immigrant and LGBTQIA communities enrich our country. In honoring queer and international diversity and resilience, it is crucial to acknowledge and address the unique obstacles faced by LGBTQIA individuals within the US immigration system. Thousands of people each year are forced to leave their families, communities, and homelands due to persecution based on gender identity and/or sexual orientation.

It may surprise some that <u>same-sex consensual conduct is criminalized in 69 countries</u>, 11 of which may legally impose the death penalty upon conviction. From 2002-2017, 11,400 LGBTQ+ asylum-based applications were filed with the US Citizenship and Immigration Services (USCIS).

Most countries do not provide legal protection to LGBTQ+ individuals who endure discrimination and may become victims of domestic violence, rape, death threats, and murder without recourse. The US has <u>legal obligations</u> to protect those who qualify as refugees from returning to threats of persecution, safety, and life. The Biden administration and the Department of State have <u>recognized and pledged</u> to protect vulnerable LGBTQ+ refugees and asylum seekers in the US. Unfortunately, human rights violations of undocumented immigrants in detention often go unreported. Most non-citizens are detained in privately-run facilities where federal safety regulations and standards of care are regularly disregarded without consequence due to a lack of government oversight. <u>Information provided by U.S.</u> <u>Immigration and Customs Enforcement (ICE)</u> shows that LGBTQ+ immigrants are detained twice as long as other immigrants and face extended periods in solitary confinement.

Reports of abuse disclose that <u>LGBTQ+</u> detainees are 97 times more likely to suffer violence and assault in detention than others. The frequent practice of placing individuals into detention centers based on their biological sex rather than their gender identity or sexual orientation makes LGBTQ+ folx targets of violence and abuse by fellow detainees or by US border guards. Furthermore, HIV-positive or transgender persons requiring medical treatment are not provided necessary medicines for adequate care. The lack of accountability puts these precious lives at significant risk.

TLC understands the challenges of immigrants, particularly those who face grave danger in their home countries due to their sexual orientation and/or gender identity, and is proud to fulfill its mission to ensure justice for low-income immigrants and migrants in Hawai'i. Together, we stand against discrimination and work towards an inclusive and accepting world where everyone is celebrated.
